Take I-55 to I-355 North, exit on Butterfield Road (Rt. 56.) Drive West on Butterfield Road about 2 miles to Route 53.

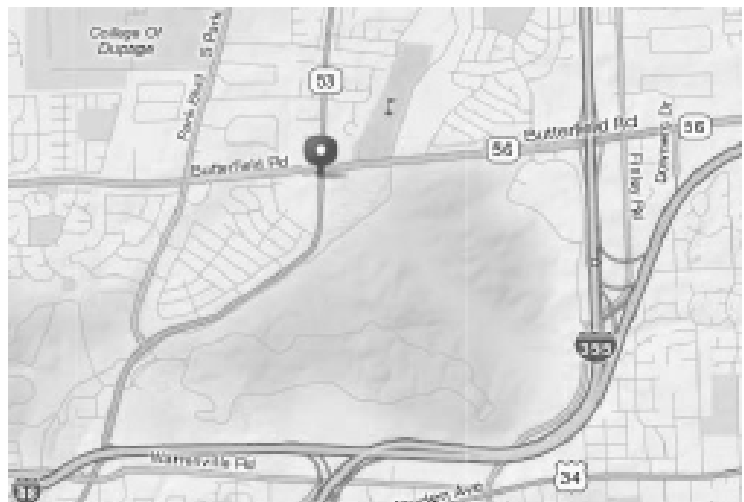
